

RURAL MUNICIPALITY OF ROLAND

BY-LAW NO. 15/79

Being a by-law of the Rural Municipality of Roland, to set the rates and regulations respecting licences.

WHEREAS section 705(3) of the Municipal Act states in part that: The council of any municipality may pass by-laws, applicable to the whole municipality or any portion thereof described in a by-law

(b) for licencing transient traders and other persons, who hawk peddle, sell, or offer to sell goods, wares, merchandise, or chattels of any kind by auction or in any other manner,

- (i) from any railway car, vehicle, or other conveyance; or
- (ii) from any tent, booth, stall, stand, or vacant lot;

on or adjacent to a highway, or at or in any other place stated in a by-law, and whether or not any such auction is conducted by a licensed auctioneer;

- (i) for requiring the owner of
 - (i) any vehicle or conveyance; or
 - (ii) any tent, booth, stall, or stand;

used for the sale of goods, wares, merchandise, or chattels of any kind

(iii) to obtain a permit therefor from the municipality before beginning operations therefrom or therein;


AND WHEREAS section 705(7) states:


Subject as in this section provided, the fee for a licence required under a by-law passed pursuant to this section shall not exceed fifty dollars, except that if the licensee is carrying on operations in the municipality at any one time from, or by means of, more than one vehicle or conveyance, an additional fee, not exceeding ten dollars, may be charged for each such additional vehicle over one.

NOW THEREFORE BE IT ENACTED as a by-law of the Rural Municipality of Roland as follows:

1. all hawkers, pedlars, transient traders and auctioneers be required to obtain a licence to operate in the Municipality of Roland.
2. That the fee for a licence, be set at fifty (\$50.00) dollars.
3. That any persons violating any provisions of this by-law shall be charged under section 195 of the Municipal Act.
